1. Welcome and Apologies

The Chair welcomed everyone to the meeting; apologies were received from Cllrs. Plumb and Mitchell.

2. Declarations of Interest and Dispensations

Cllrs. White and Hunt declared an interest in Item 5.4.

3. Minutes of the Previous Meeting

Proposed by Cllr. White and seconded by Cllr. Hyde, the Minutes of the Monthly Parish Council meeting held on the 13th August, 2014, were agreed and signed as a true transcript.

4. Visitors/Public Time

- 1. **Visitors** No comments raised.
- 2. **County and Borough Councillors** Borough Cllr. Stokes advised that work to the speed ramp between Bittern Road and Woodpecker Drive is commencing next week; has received a complaint regarding weekend working and dust relating to the Persimmon site; been dealing with the The Barn, problems at Iwade Speedway and is helping a disabled resident who needs a dropped kerb installed to the front of his property.
- 3. **Community Warden (Nick Mayatt)/PCSO** Nick's report has been circulated to Members and contents noted, issues covered traffic problems in Helen Thompson Close; fly tipping instances in Old Ferry Road and Ferry Road. Clerk to check with Swale Cleansing to see if they can do anything to stop the fly tipping.

5. Matters Arising from the Minutes

- 1. **Twinning** Cllr. Hyde reported that Swale Borough Council is very interested and will assist with this; it will be a community/educational link. Cllr. Rook will discuss twinning with the resident who has links with Malawi; Clerk to place on October Agenda.

- 2. **Persimmon Development** Clerk still waiting for a firm date from Swale to discuss the Parish Council's complaint. Cllr. Gale advised that Lorries are using School Lane again. *Action: Clerk*
- 3. **Countrystyle Update** Place on October Agenda. The Chair advised that a meeting will be set up to include the Parish Council and representatives from various companies, to be held at Knauf, to discuss the upgrading of the old Ridham Dock Road.

- 5. **Sheppey Crossing Concerns** The Parish Council was dismayed to see that County Cllr. Truelove voted against lowering the speed limit on this road. Gordon Henderson, M.P. will be holding a meeting regarding the bridge; Cllrs. Hunt and Gale to attend.

- 6. **Grass Cutting Verges –** Proposed by Cllr. Gale and seconded by Cllr. Wastall, all agreed to accept the quote of £300.93p plus VAT for the period 1st October, 2014 to 31st March, 2015 and to provisionally accept the quote for 2015/16 of £601.86 plus indexation plus VAT, subject to confirmation of the exact cost by Swale Borough Council.

Village Hall Disco and Emergency Services Use Clerk has spoken to the Village Hall Chair who advised that the Fire Service is being charges £15 a day to use the hall site as the Committee is not able to hire it out on these days. Following concerns raised regarding adults being CRB checked; the presence of a qualified First Aider and sufficient number of adults to children the Parish Council understands the Disco was cancelled.

6. Planning

New Applications:

- 1. 14/501315/AMRCON/EMEI The conditions are no longer relevant or necessary in the context of the amended proposal (see drawing 1308/3A) for a permanent agricultural access (amended) and agricultural hard standing. Condition 2 to be varied to allow permanent retention of approx. 70m of haul road for use as an agricultural hard standing; retained and amended (gated) agricultural access to Grovehurst Road; deletion of all other conditions attached to planning permission SW/09/0755-Iwade East Development Site, Sheppey Way, Iwade, Kent Agreed to respond that the Parish Council is disappointed that the condition has not been adhered to and object on this ground. Members and nearby residents are unhappy that the land has been left in an unacceptable state, contrary to the provisions of the original planning condition. If Swale Borough Council are minded to agree this application, the Parish Council request that:
 - security gates are installed to stop unwanted use
 - the hard standing is not used for any storage or overnight keeping of vehicles, and
 - heavy planting screening is carried out to minimise the visual impact from the road.
- 2. 14/501060/REM/ROMC Application for reserved matter for recreation area including 2 football pitches, pavilion, play area and associate hard and soft landscaping Iwade South West Development Site, School Lane, Iwade Members raised no objection to this application. However, referring to drawing reference 2226_DR_114, the Parish Council would ask that the Playbark (because of its nature to break down and deteriorate) shown in the S.E. corner of the LEAP is replaced with artificial grass to provide a clean sitting area for families.

3. 14/500690/FULL/EMEI – Erection of a single storey rear extension, replacement windows and doors and replacement of roof tiles – 35 School Lane, Iwade, ME9 8SE Members raised no objection to this application.
